The meat processing industry has been designated a high-risk industry and as such plants must demonstrate that they have appropriate protocols in place, in the event of a COVID-19 outbreak at their facility. Current State-based training programs are generic in nature and do not consider the intricacies of the food production industry, specifically red meat processing.

AMPC's COVID-19 Marshal training, delivered in collaboration with Respond Global and Response Group, includes specific examples of operational procedures as they relate to meat processing plants, assisting in better learning outcomes for participants.

At the end of the course, participants will have a firm understanding of how to support their plant's COVID-Safe Plan and be empowered to assist all employees in the continuing practical implementation of important COVID-19 mitigation measures.
